WRC RECERTIFICATIONS

Henderson County (WR) – They meet the main criteria for being Work Ready, but there could be some discussion on whether their application demonstrates the continued work that the community needs to stay on track. For example, initiatives are mentioned for underserved populations, but only what was going to be done in 2020.

WRC EXTENSIONS

Jackson County (WR) 12-month extension – I think that this extension could be approved easily for one year.

Rowan County (WRIP) 3-year extension – I also think that this extension could be approved easily for three years, they are doing good work but want more time to improve even more.
