Everyone gave a summary of their agency, and their role in it, with a quick description of their agency's workforce programs. The members were asked to provide a quick couple paragraph summary of this, to Sara Jaggers their KWIB staff support for the committee, so that the committee can begin to build off Donietta's USDOL Resource Map for Veteran's Workforce Issues in Kentucky. The Committee intends to raise awareness and connect all the programs, so that all our partners in the ecosystem know what the other's do, and work on streamlining referrals.

SkillBridge (SB)/Career Skills Program (CSP)

Dallas Kratzer walked through SkillBridge; stated that Kentucky needs to be more than just "military friendly", wants to be "military-ready" and "military engaged"! He then shared successes in Hopkinsville, Ft. Campbell and Frankfort with police and fire fighters creating pathways for on-the-job training into full employment.

The SB/CSP is important because there are between 3,000 to 4,000 servicemembers returning to Kentucky once they've completed their military service, and can help them find work quicker. Additionally, there are almost 300,000 veterans in KY.

- Several are seeing where commanders are not signing off on the CSP or SkillBridge pathway;
- There are some CSP paths that don't result in a job placement;
- Communication and clear direction to DOD and employers needed about pathway.

What is SkillBridge (SB)/Career Skills Program (CSP)?

SkillBridge is a program developed by the U.S. Department of Defense. It allows civilian businesses to provide job skills training to service members during their last six months of their military service.

All Branches of the Military, US Army National Guard and Reservist are eligible to participate in these programs, but first must have approval from their Chain of Command.



What are benefits to the Employer?

- * Opportunity to engage servicemembers as they are transitioning out of the military
- * Value of hiring dependable, highly skilled, servicemembers
- * Not committed to hire the participant intent is to help servicemembers to better understand civilian work and life




General information for Skillbridge partners

- *The Department of Defense would like the program within a 50 mile radius however, with additional approval they can go beyond that area * The Service member must have a high probability of employment after the program has ended
- * Service members are not paid by the SkillBridge partner, they still receive full benefits from the military
- *Each branch of service have their own processes and procedures for entering into an agreement




