Pam Moore, CTE talked through information required to submit requesting additions or changes to approved certifications. She shared that the KWIB staff will be adding a form to the kwib.ky.gov site in the next month that can be accessed, tracked and monitored for processing with the CTE and BEAT (Business Education Alignment Task Force) teams.

Scott U'Sellis, CTE walked through the list of new additions or vendor changed certifications for review and discussion. There was discussion around some of the information technology items. Information provided by **Sean Jackson** shared the following in the chat:

- The MTA bundle is very popular and we currently have a total request number of 780 exam vouchers from all MTA areas from the CS/IT Academy.
- Certiport is also seeking other endorsers for that exam bundle to 'beef-up' the street credit for those exams. But they are an 'apples-to-apples' replacement when you look at the exam objective domains

A **motion to recommend** this new list to the KWIB Board, through the Education attainment and Employer engagement committee **was made by Tara Johnson-Noem and a second motion was made by Kim Humphrey**. The motion was unanimously approved with no one dissenting.

Ms. Satterwhite mentioned that we have 2022 meeting dates set and that KWIB staff will share with the committee after the meeting.




