## 11:34am CALL TO ORDER

**Kevin Smith, KWIB Chair** called the meeting to order. Kevin asked the committee if there were any changes to previous meeting minutes from March 15th, 2021. No changes identified. Heidi Margulis motioned to accept the minutes; Amy Luttrell seconded the motion; motion carried.

## **EDWC updates**

John Lyons, Executive Director, KWIB talked about the last several weeks initiatives by the Cabinet regarding community work programs and Pre-ets (pre-employment workshops); Beth Davisson added that the "skills bill" recently passed should help to implement this.

## KWIB updates

John shared that interviews have begun with Deloitte leading for the **pilot initiative**, "Putting **Kentuckian's First".** In the next couple of weeks, KWIB will firm up objectives and steps to achieve clear deliverables; Amy Luttrell asked that we add a Goodwill representative(s). **Doodle polls** to be sent to the board for weeks of May 3 and May 17 for their participation in the "Greenhouse labs".

**Work search requirement** discussions are ongoing within DOL and changes may be coming in May. More information to follow.

**DOL / WIOA audit** suggested an updated WIOA Record Retention Policy that made it clear this schedule applied to all contracted WIOA Partners. John walked through briefly. **KWIB staff** will help identify if any schedule changes were part of this policy.

## Committee updates:

Education attainment / Employer engagement – Beth Davisson, Chair

- Will continue monthly meetings for now to continue work in the following:
  - CTE Certification Continuous Improvement / employer engagement
  - Sector Strategies /Career Pathways
  - Higher Education opportunities (apprenticeships, internships, mentorships for minorities and low-income individuals)

## Workforce Participation and Sustainability - Amy Luttrell, Chair

Continuing to add partners to the committee. A budget bill for Goodwill to begin an **adult high school** passed. This will be for those older than K-12 age who need to finish high school and offer in person sessions. There are 400,000 Kentuckians without a high school diploma. Will offer training on entry-level and skilled jobs and will open summer of 2022.

The committee will focus on broadband opportunities for the state, especially in rural areas. There is value in what **TeleWorks** is doing and we want to extend that value to other areas allowing individuals to work remotely.

Amy is speaking with the Atlanta Federal Reserve on additional opportunities for the **benefit cliff calculator**. We can add information by industry, and her committee will begin to coordinate meetings with KY Stats, Atlanta, Louisville and St. Louis.

## Resource Alignment and Funding – Kim Menke, Chair

The committee is working on the following:

- Funding and program activities within the resource mapping; will break his committee into groups
- Reviewing policy 15-002 further

## Work Ready Communities Committee - Lori Ulrich, Chair

Working on review of 13 applications from counties; next meeting on April 23. Lori did bring up her concern for some counties not responding. The coordinators will continue to encourage and offer best practice examples for participation.

## Perkins Leadership update - John Lyons

KWIB will pull together the team in the upcoming weeks to talk through the process and recommend any changes to the Executive committee for review. Reviewing / revising applications will be part of the process.

### ADMINISTRATION AND CABINET UPDATES:

**Lieutenant Governor Jacqueline Coleman** spoke to the continued administrative goals and initiatives that includes: "cradle to career" focus; broadband initiatives, and the focus of the governor's budgets to invest in the economy and workforce and education of Kentucky.

**Mary Pat Regan, Deputy Secretary** of the Education and Workforce Development Cabinet provided a deeper dive into the broadband initiatives (broadband info - <u>https://educationcabinet.ky.gov/pages/default.asp</u>) and on the recently rolled out "Discover YOU" Virtual Bus Tour (information can be found on the cabinet website - <u>https://educationcabinet.ky.gov/Initiatives/Pages/VBT.aspx</u>.

**Buddy Hoskinson, Director, Office of Unemployment Insurance**, provided updates on initiatives of the Unemployment office; April 15<sup>th</sup>; regional career centers will be opening back up (information on processes forthcoming); a new call center will be opening soon; with regard to work search requirements, deeper questions have been added to the UI claims for review.

**Eric Friedlander, Secretary for the Cabinet for Health and Family Services (CHFS)** provided updates from the cabinet to local communities; examples included childcare and promoting living wage jobs and entrepreneurship, even through and especially in response to the pandemic.

John Lyons, Executive Director provided an overview of the Work Ready Strategic plan implementation efforts. He walked through a new project, a pilot program for "Putting Kentuckians First" that will improve our workforce participation. The pilot population is those recently released from incarceration. Meetings for the first phase of this pilot will begin in April and continue through May.

The Perkins committee and Executive committee have made Perkins Leadership recommendations. Scott Pierce motioned to accept the recommendations and seconded by Kim Menke. A motion was approved unanimously by the board with no dissenting votes.

- Amy Luttrell, Workforce Participation and Sustainability committee Chair about the committee's focus in 2021. In rural and urban areas, technology is a clear focus. Eastern Kentucky Employment Program (EKCEP) has a technological employment program called "TeleWorks". The committee agrees with the justice-involved population as the focus for the pilot John lifted. Amy spoke about exploring ways to use the benefit calculator to change policy as necessary. Amy introduced Johnny Pittman as the new Chair of the Opportunity Youth sub-committee.
- Kim Menke, Resource Alignment and Funding committee Chair updated the board on the review of the Policy 15-002 (the WIOA policy on Interlocal agreements). There are additional requests and changes to the policy that are under review and recommendations brought to the full board in the May meeting.
- Beth Davisson, Education attainment and employer engagement Chair provided updates from the committee works over the last two months. She introduced a discussion regarding internship opportunities within higher education and invited Dr. OJ Oleka (AIKCU) to speak about these opportunities, to make good policy, to build these talent pipelines with intention.

She updated the board on the newly created sub-committee, CTE Certification Continuous Improvement. Data is being gathered on a recently submitted survey, in partnership with the Local WIB Director's. Good work is being started and we look forward to upcoming meetings.

- Lori Ulrich, Work Ready Communities committee Chair updated the board on the work of the team reviewing 13 applications currently. She offered information on reaching out to Jacob McAndrews (Jacob.mcandrews@ky.gov) and Sara Jaggers (sara.jaggers@ky.gov), Work Ready Coordinators within the KWIB, dedicated to working with counties. Recommendations will be made to the Executive Committee and the full board for the May 20, 2021 meeting.
- John Lyons updated and lifted his appreciation to the board that ALL board members are involved in committee work. He invited continued participation and non-board members to reach out to <a href="mailto:Debbie.dennison@ky.gov">Debbie.dennison@ky.gov</a> if they would like to be a part of any of the committees. He wants board members to be involved in upcoming meetings for the pilot program and will be reaching out for their participation.



# Putting Kentuckians First Lab 1 Feedback


**1.** How helpful were the following Lab 1 activities in developing a successful pilot for justice-involved individuals:

Department of Corrections is a valuable tool and organization. However we must expand our minds to the "reentry" or "justice involved" population is much wider than individuals getting out of Prison or Incarceration. Many offenses require no initial jail time however many of the same barriers are present.

Community based early intervention at the county level (judicially) and a community level (for businesses and organizations) is 100% KEY in reducing recidivism, and preventing impactful incarceration. We as a society and the department of corrections are to RE- active - a pro active approach to change this trajectory and intervene in peoples lives can set the stage for progress.

Can we invite someone from Social Security Services to discuss solutions for social security cards in local jails and detention centers?

#### Funding to help customer

very helpful, eye-opening to the needs and obstacles of inmates reentering society. We need to do a better job of acknowledging the fact that 85% of those incarcerated will rejoin society at some point. Programs like this one helps us to better understand the challenges they face and the work we need to do!

## 1:31 am CALL TO ORDER

**Kevin Smith, KWIB Chair** called the meeting to order. Kevin talked briefly about the Federal plans for continuing unemployment insurance and said that Kentucky businesses are frustrated. Concerns for Kentucky's health and, workforce and education are in crisis. We continue to see an overdosing crisis. It is imperative to get people working again. The longer they are out of the workforce, the less likely they are to return. Childcare and transportation continue to be biggest barriers within the state.

Kevin asked the committee if there were any changes to previous meeting minutes from April 8th, 2021. The only change was a date modification. Heidi Margulis motioned to accept the minutes; Kim Menke seconded the motion; motion carried.

## EDWC updates

**John Lyons, Executive Director, KWIB** lifted an upcoming inaugural Virtual Town Hall in late June. These will continue on a quarterly basis about the health of the Commonwealth.

## **KWIB updates**

**John Lyons** shared that the first Strategy Lab was a success and we are planning for the second. The first lab identified barriers to focus on in the coming weeks to get those recently released from incarceration back to work. The second lab will begin to focus on the design and resources needed to move forward.

**Amy Luttrell** lifted that as we design a path, we need to align existing resources so as not to be duplicative in efforts.

## KY Stats

**Scott Secamiglio**, Director of Strategic Analysis with KY Stats provided an update to the information gathered within the site that now includes surrounding states stats compared to Kentucky's.

## **Committee updates:**

## Education attainment / Employer engagement – Beth Davisson, Chair

The CTE Certification Continuous Improvement sub-committee and the Education attainment and Employer engagement committee is recommending a motion to the KWIB board to Move to a Dynamic certification list as opposed to a Static List for additions to the list during the year, but not for removal. Scott Pierce motioned to move to the board and Heidi Margulis seconded the motion with non-dissenting.

**John Lyons** lifted that the Perkins Leadership team needs to reconvene; focus the next round of applications on work-based learning and further engaging employers; include on the job training and offer flexibility in alignment of goals needs to be included in the focus.

The Sector Strategies sub-committee will be introduced to the KWIB Board with LaKisha Miller, TPM KY Chamber, leading.

## Resource Alignment and Funding – Kim Menke, Chair

The committee continues to review the funding and policies for future action.

## Workforce Participation and Sustainability – Amy Luttrell, Chair

This committee continues to work on removing barriers for underserved populations. Discussions around vouchers for childcare and continuing conversations with WIB directors and entities about additional barriers to remove. Increasing broadband solutions across the state also continues to be a focus. The Opportunity Youth sub-committee will receive information on research conducted around programs and funding for youth in the state.
