Review of subcommittee objectives:

Finding tangible ways to adjust to a changing workforce and employment landscape.

Discussion:

Kentucky is set to receive over \$157M in federal funds. How should we utilize the influx of federal funds entering our state, such as the American Rescue Plan Act (ARPA), to ensure Kentuckians are upskilled and trained in the ways needed to support our economy?

- Identified hurdles to expanding the workforce:
 - Transportation. Making sure people can get to/from trainings and work.
 - Messaging. Making sure people understand their options, enjoy their job.
 - Bus to Business, Work-Based Learning, engaging adults interested in a career change.
 - Willingness to relocate. Engaging students and *parents* in opportunities throughout the state.
- What do we need to do in order to use these funds effectively?
 - Consistent messaging. Identify target groups, identifying existing programs, make sure all
 partners and stakeholders are working together and eliminate redundancies.
 - Identify how many students are completing trainings/certifications/career pathways in high demand fields by county/region. Would make it easier to connect employers and graduates. In the works in the South Central region, waiting for the MOU to be completed.
 - Collaboration amongst multiple employers and educators for a holistic sector strategy for engagement.
