G. OVERDUE COUNTIES

 A one-time, 12 month extension has been issued to counties that have failed to submit due to factors surrounding COVID-19.

- Currently 13 counties are overdue, which we should discuss how to proceed. Staff Recommendations:
 - i. Current overdue counties will have until the September 3rd deadline to apply for recertification. If they fail to do so, they will move back into the formative stage and lose their certification.
 - ii. Create a 6-month probationary period for future counties.

LETTERS OF INTENT

 Monroe and Simpson Counties submitted their "Letter of Intent" to become Work Ready, which will be shared with the KWIB Board.

WORK READY APPLICATION –

 Meade County (WR) -Committee members reviewed Meade County's WR application and were satisfied with the additional information provided as requested. The committee unanimously agreed to recommend Meade County as Work Ready to the KWIB Board.

▶ WORK READY/ Work Ready in Progress RECERTIFICATIONS

Five (5) counties submitted applications to recertify their Work Ready Community status.

- Allen County (WRiP) The committee decided to send a formal letter requesting additional information and explaining their options to resubmit for the next application round.
- Fleming County (WR) The committee decided to send a formal letter explaining that the
 application did not meet the requirements, and explaining the options available: submit a
 request for the 12-month covid extension, by June 4, 2021 or with current application,
 dropdown to a WRiP status.
- Hardin County (WR) The committee decided to move forward with recertification; Anna Larson motioned to approved; Jeremy Faulkner provided second motion to approve. The committee unanimously agreed.
- Hopkins County (WR) The committee decided to send a formal letter requesting additional information and explaining their options to resubmit for the next application round. Jacob McAndrews will help facilitate additional discussion for this applicant.
- Nelson County (WR) The committee decided to move forward with recommending recertification to the KWIB Board.

The committee agreed that additional information was required by Allen, Fleming, and Hopkins counties and will not currently be recommended for approval by the KWIB Board. A formal letter, by John Lyons, will explain the recommendation by the committee, asking for a response or update to the application by June 4, 2021.

➤ WORK READY / Work Ready in Progress EXTENSIONS

Seven (7) counties submitted applications for extensions. Two extension options are available: 12-month COVID Extension (available through 2021); 3-year Extension request

- <u>Christian County (WR)</u> The committee confirmed to move forward with recommending this 12-month Covid Extension request to the KWIB Board.
- Graves County (WR) The committee confirmed to move forward with recommending this
 12-month Covid Extension request to the KWIB Board.
- Owen County (WR) The committee confirmed to move forward with recommending this
 12-month Covid Extension request to the KWIB Board.
- Pulaski County (WR) The committee confirmed to move forward with recommending this
 12-month Covid Extension request to the KWIB Board.
- Garrard County (WR) The committee confirmed to move forward with recommending this
 3-year Extension request to the KWIB Board
- Scott County (WR) The committee confirmed to move forward with recommending this 3year Extension request to the KWIB Board
- <u>Jackson County (WRiP)</u> The committee decided to send a formal letter requesting additional information and explaining their options to resubmit for the next application round.

A formal letter, by John Lyons, will be sent to Jackson County explaining the recommendation by the committee, asking for additional information by September 3, 2021.

> OVERDUE COUNTIES

The committee discussed the following options for maintaining work ready status for each overdue county. A one-time, 12 month extension, has been extended to several counties that have failed to submit requests and applications due to factors surrounding COVID-19. This one-time option will not count against a one-time 3-year extension option.

Currently 13 counties are overdue. A formal letter, signed by John Lyons, KWIB Executive Director, will be sent to these counties recommending them to apply for recertification by September 3, 2021 with clear verbiage that identifies their response to application questions. If the county fails to submit by that time, they will move back into the formative stage and lose their certification. The Work Ready Coordinators will follow up via email with *each* impacted county.

> CRITERIA/APPLICATION MODIFICATIONS

Jacob McAndrews, Work Ready Coordinator, walked through several data and response impacts regarding criteria and application responses as follows:

<u>Associates Degree Exception</u> -

KYSTATS has stopped gathering the data in the format described in the exception. Rural counties find the exception valuable, so the group decided that more research is necessary. Jacob will set up a meeting with Scott (KYSTATS), Lori, and Sara to discuss alternatives to assist rural counties as needed. If any committee members would like to be included in this side meeting, please reach out to Jacob or Sara.

Narrative #9 -

The supply/demand is not available using key sectors (see above). The committee and KY Stats will need to offer solutions on how counties can demonstrate their commitment to meeting the future workforce needs. Jacob will set up a meeting with Scott (KYSTATS), Lori, and Sara to discuss alternatives to assist rural counties as needed. If any committee members would like to be included in this side meeting, please reach out to Jacob or Sara.
