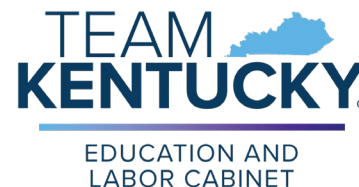

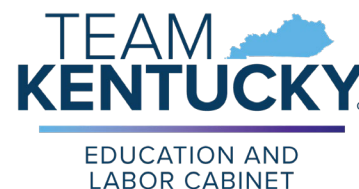

1:31 pm MEETING CALLED TO ORDER

Dr. Mike Yoder, Commissioner of the Kentucky Department of Workforce Development (DWD), opened the meeting by introducing himself and thanking Lori Ulrich for leading the previous meeting and the attendees for their participation. He lifted the Governor's workforce-focused investments in Kentucky and highlighted the Collaborative Board's role in supporting KWIB's strategy through the ten local boards. He introduced Dr. Matt Berry and Sam Keathley, Kentucky Center for Statistics (KYSTATS), commending their contributions to shaping workforce strategy for cross-sector collaborations to identify future high-demand, living-wage jobs.

Overview: Kentucky's Top Sectors & Good Jobs

Alisher Burikhanov, Executive Director of the Kentucky Workforce Innovation Board (KWIB), welcomed and introduced sector leaders to discuss workforce challenges and solutions across key industries in Kentucky. He reminded the board of Kentucky's top five sectors: Healthcare, Manufacturing & Logistics, Education, Construction, and Professional, Scientific, & Technical Services. **Jacob McAndrews, Kentucky Chamber Foundation**, represented the Healthcare sector; **Mike Buckentin, Metals Innovation Initiative (MI2)**, represented the Manufacturing & Logistics sector; **Dr. Jim Flynn, Kentucky Association of School Superintendents**, represented the Education sector; and **Jason Shultz, Greater Louisville Building and Construction Trades Council**, represented the Construction sector.

Kentucky's Top Sectors Overview

The healthcare discussion focused on addressing workforce shortages by involving retired nurses as instructors, proactively preparing staff nearing retirement for teaching roles, and emphasizing the need for soft skills like

communication. It also highlighted the need for broader youth recruitment strategies, moving beyond family connections, and targeting underrepresented groups, including immigrants and formerly incarcerated individuals, to fill gaps in the workforce.

The manufacturing discussion focused on strengthening partnerships between businesses and schools to provide hands-on learning and workforce training. It highlighted examples like companies funding labs or relocating classrooms into manufacturing plants to offer real-world experience. Emphasis was made on the importance of industry involvement in education to build talent pipelines and align curricula with the needs of high-demand sectors like manufacturing.

The construction conversation focused on promoting construction as a legitimate, high-paying career, not just a fallback option. It emphasized the need to shift societal views, introduce students to trades early, and align education systems with workforce needs. Discussion advocating for more focus on skilled trades and creating demand-driven models to address workforce shortages.

The education discussion centered on addressing continued misalignment between education and workforce needs. It highlighted the importance of creating demand-driven education systems, where local communities and employers help shape priorities. Emphasized was the need for streamlining teacher certification and promoting industry-education partnerships to better align curricula with real-world job market demands.

Group Discussion – Opportunities for Collaboration & Innovation

Discussion focused on aligning Kentucky's education system with workforce needs through collaboration and reform. Strategies to address teacher shortages in high-demand fields included engaging retired professionals, increasing certifications, and exploring alternative compensation models. The group also emphasized expanding career exposure for students, increasing employer involvement in schools, and ensuring workforce pipelines are inclusive of underserved groups.

Initiatives like the "[United We Learn](#)" accountability framework were cited as potential tools for achieving the goal. The group called for stronger cross-sector partnerships and actionable steps to modernize both education and workforce development systems across Kentucky. To further these efforts, the board recommended incorporating more industry experts into Career and Technical Education (CTE) programs and scaling successful regional initiatives, such as [SCK Launch](#) in Bowling Green. This program, a collaboration between the local chamber, local school districts and businesses, provides middle school students with valuable career exposure and could be expanded statewide.

The discussion also highlighted several resources, including "[Futuriti](#)", which focuses on top sectors for students; "[Ready for Industry](#)", a career exposure initiative by the Department of Workforce Development; and "[Pathful](#)", a system designed to engage students in career development. **Chris Sanders, Deputy Executive Director – Office of Educational Programs**, introduced "Pathful", a workforce-ready platform used in over 500 K-12 sites across Kentucky, which helps students explore careers through video content and a school-based social media-style system. The platform supports career awareness and skill-building from kindergarten through 12th grade, connecting education with industry. Businesses can participate by emailing everybodycounts@ky.gov to create custom content or take part in virtual tours, such as those with Amtech, Spy Coast Farms, and the Operating Engineers Local 181.

Updates on Collaborative Activities

Alisher thanked participants for their engagement and emphasized the importance of collaboration in workforce development efforts. He provided updates on several key initiatives, including the [Jobs on Day One program](#)—a training partnership, funded in part by the Governor's the Statewide Reserve Fund. This program has helped formerly incarcerated individuals transition into skilled trades.

He also highlighted the launch of the [Governor's Council of Second Chance Employers](#), a business-led group promoting fair hiring practices for those with criminal records. Council members include representatives from various sectors such as manufacturing and food service. In support, the Governor's office [released videos](#) this initiative. Additionally, the Team Kentucky Office of Reentry Services has been established to provide a statewide strategy for helping individuals

exiting incarceration successfully reintegrate into the workforce. **Natalie Burikhanov, Legislative Director for the Kentucky Justice and Public Safety Cabinet** will serve as Executive Director of this office.

He acknowledged the significant contributions of **Everett Bracken, Program Administrator, Kentucky Department for Veteran Affairs (KDVA)**, especially in veteran workforce initiatives like the [Commonwealth Job Fair](#), which connects veterans and job seekers across Kentucky with employers. Employers had early access to resumes and conducted live interviews, with some pre-screening candidates in advance. The initiative also received high-level support, with promotional videos from the Governor, Lieutenant Governor, and Secretary of State. The program, which runs through December, is designed to make hiring easy for businesses and to help retain military talent in Kentucky. Everett has proposed continued funding for the next fiscal year.

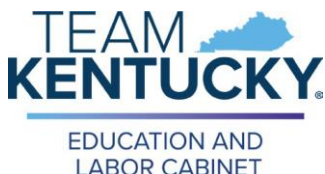
THE SOLUTION

Education & Workforce Collaborative - State of the Workforce Funding Report

Per the [Executive Order 2020-551](#), the Education and Workforce Collaborative will be compiling 2022-2025 funding report identifying all federal and state funded workforce-related activities. Including funding streams for education, training, support services, and career service activities in the past three programmatic years provided by the Collaborative's respective agencies or entities.

The funding report shall indicate, to the extent feasible, the return on investment (ROI) for each stream. To determine ROI, the Kentucky Workforce Innovation Board (KWIB) has identified three ROI elements: (1) number participants, (2) number of placements, and (3) average wages.

Timeline: Request will be sent 7/21 to Collaborative members with the due date of 8/22.

Necessary Funding Data & Steps

1. Identify allocated funding for:

- PY22 (July 1st, 2022 – June 30th, 2023)
- PY23 (July 1st, 2023 – June 30th, 2024)
- PY24 (July 1st, 2024 – June 30th, 2025)

2. Specify if funding is federal, state, or combined (if combined, what percentage is federal and what percentage is state?)

3. Identify the type of activity per stream:

- Education
- Training
- Support Services
- Career Services

4. Provide the eligibility requirements for each funding stream

5. Identify per funding source:

- Number of individuals served
- Number of individuals placed
- Average wages of individuals placed

If funding is meant to serve businesses, identify the number of companies served.

Funding Streams Definitions

Education: investment used to for long term career preparation, examples include higher education degrees, certificates, certifications, credentials, digital badging, integrated education programs, etc.

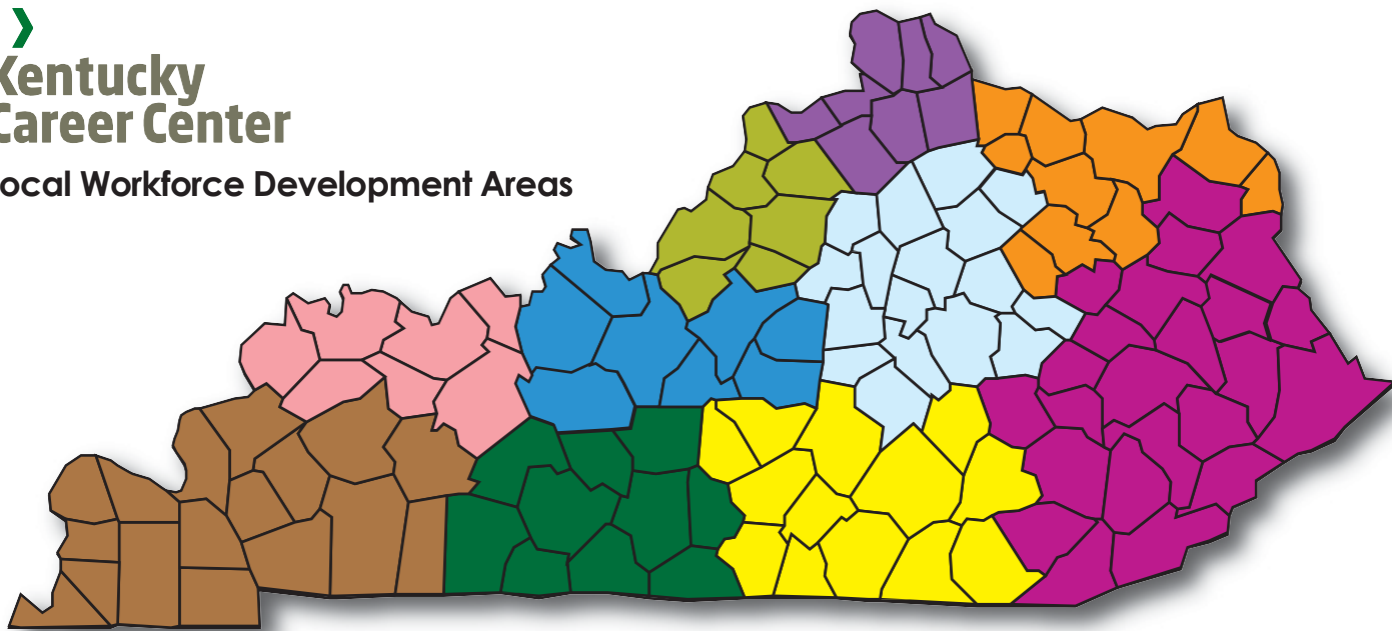
Training: investment in programs that are occupation specific, examples: on-the-job training, incumbent worker training, internships, pre-apprenticeships, registered apprenticeships, and career pathways exposure.

Supportive Services: investment in services such as transportation, childcare, dependent care, housing, and needs related payments, linkage to community services, assistance with educational training, reasonable accommodations for youth with disabilities, referral to medical services, and assistance with uniforms and other appropriate work attire and work-related tools.

Career Services: provision of services related to employment and career assistance, such as career coaching, career awareness, career exploration, labor market information sharing, resume building, interview skills, and job placement services.
