  - Career Programs & Pathways: Instructional resources for educators, fosters business and industry partnerships, and supports the alignment of secondary and postsecondary pathways. (\$449,795)

- KCTCS and UofL submitted an addendum immediately following the interviews because the outdated version they used didn't include Section M that addressed special populations. Both answered how their projects would serve one or more of the special populations identified in Perkins.
- Discussion of new position created with Perkins funding that are only supported for up to 3 years, after which the entity must determine if they can continue to fund that position or if needs to be dissolved.
- Discussion of reporting accountability, return on investment, and yearly monitoring for each program. OCTE program lead, Lori Looney indicated that an annual report that is requested of each applicant could be shared with this Leadership Fund workgroup.

Sending the approved recommendations to the Education Attainment Committee prior to the Kentucky Workforce Innovation Board for final approval.
