Beth Davisson, Committee Chair, welcomed and thanked everyone for their commitment, provided the goal of the committee and walked through the agenda. She asked KWIB staff to share the overall goals and objectives in the post meeting packet.

Beth introduced **Sara Tracy,** KY Chamber to provide updates from the Sector Strategy committee and their working groups.

Sector Strategy sub-committee update

Sara Tracy, Executive Director of the Total Pipeline Management (TPM) of the Kentucky Chamber and Chair of this sub-committee shared updates. The sub-committee is reviewing how to annually review sectors and the next steps include review of KY stats data in the smaller working group. They will lift results to the upcoming Sector Strategy committee meeting on May 25, 2022.

Additionally, a joint sub-committee with the Opportunity Youth / Young Adults sub-committee created a working group to build a Work-based Learning Guide to market and share with employers. A glossary as well as resources will be part of the toolkit. The working group is reviewing other states information and will be pulling together sections as it relates to the needs of Kentucky.

Beth introduced David Horseman, KDE Association Commissioner, to provide updates within the CTE Certification Review sub-committee.

CTE Certification Review sub-committee update

David Horseman, Associate Commissioner of the Office of Career and Technical Education (OCTE) walked through the CTE process and introduced **Regan Satterwhite**, who walked through the certifications received through the KWIB online site request. Each certification received is reviewed by the BEAT team.

Discussion and questions for clarification were raised by Scott Pierce, Dallas Kratzer, Dr. Gregory and Sara Tracy. Beth Davisson asked if anyone opposed recommending the certifications as a group, or should they motion individually. There was no one opposition. Beth asked if anyone moved to recommend the group of certifications for KWIB Board review on May 19, 2022. **Scott Pierce** *motioned to recommend*; **John Greene** *seconded the motion*. Motion passed with no dissenting votes.

Regan added that the dynamic certification list link has now been added to the KWIB site for review.

<u>Kentucky Community and Technical College System (KCTCS)</u> provided presentations on programs created as additional resources for the workforce ecosystem.

Kentucky Education to Workforce GIS Application

Roderick Jones, Ph.D. provided a walk through of the GIS application created in conjunction with KYSTATS. There was discussion around the tool and Beth commented that further collaboration with Veterans, TPM and CPE folks would happen.

ALIGN Project and Associated Field Guide

Harmony Little, Executive Director of Credentialing Strategies, with the Chancellor's Office provided a PowerPoint presentation of an 18-month planning process around a *Competency Based Education Network*, led by KCTCS faculty and staff. The process included a design of what a future educational model could look like; evaluation of what would be needed to launch and sustain such a model; and to make recommendations on whether to implement a new model based on the learnings from the year-long process. New Business



Education Attainment and Employers Engagement

• <u>Goals</u> – Actively engage employers to drive Kentucky's workforce development system; To align and integrate P-12, adult education and postsecondary education to provide lifelong opportunities for Kentuckians that prepare them for the rapidly shifting realities of work in the future.

• Objectives include:

- > Create a workforce development system that is valued by employers.
- > Establish a clear channel for employer engagement in workforce development services.
- Increase the number of employers participating in work-based learning experiences and apprenticeships, while also establishing employer champions.
- ➤ Engage employers in education efforts from early childhood through kindergarten, Grade 12 and postsecondary study.
- ➤ Leverage employer data in workforce projections and training needs, using the talent pieling management system of the KY Chamber of Commerce and a revamped business service team network.

Education Attainment and Employers Engagement

• Objectives (continued):

- ➤ Increase career exploration opportunities while students are in P-12; provide all students an opportunity to earn a certificate or credential prior to graduation, with emphasis on those credentials where dual secondary / postsecondary academic credit is awarded.
- ➤ Review and adjust the structure (locations, pathways and resources) of Pre-K through postsecondary delivery to align and integrate the Commonwealth's educational infrastructure based on employer needs.
- ➤ Increase awareness of all market-relevant career pathways among students, educators, guidance counselors, career counselors and parents.
- Improve the sharing and use of data to inform the ongoing curriculum design for P-12 and postsecondary institutions.
- ➤ Create opportunities for early, mid, and later-career learning for all Kentucky workers to provide a range of learning opportunities for growth, upskilling and adaptation to changes in the nature and structure of work.
- ➤ Encourage the agility, responsiveness and desire for lifelong learning among older Kentucky workers.

18-MONTH PLANNING PROCESS

KCTCS was provided charitable funding by the Ascendium Education Group, through the KCTCS Foundation, to engage in a comprehensive planning process, supported by national experts from the Competency Based Education Network, led by KCTCS faculty and staff.

- Design what a future educational model could look like
- Evaluate what would be needed to launch and sustain such a model
- Make recommendation on whether to implement a new model based on learnings from a year-long planning process



WHY

- > The disconnect between education and the workforce
- > More than 40% of recent college graduates were underemployed
- In Kentucky, the knowledge and skills gap is particularly pronounced in "middle skills" roles that require postsecondary education but not necessarily a bachelor's degree
- > Desire to expand access to adult students and improve completion rates



THE VISION

- A community that surrounds each learner with the services and supports needed for success
- Flexibility to ensure all learners have the opportunity to pursue education and persist to completion
- Instruction that leads to workforce readiness through the demonstration of required knowledge and skills needed by employers both now and in the future



COMPETENCY BASED EDUCATION

Provides an opportunity for:

- Learning at own pace (slower or faster)
- Accelerated credential attainment
- > Reduced education costs
- More market-relevant skills
- > Deeper employer collaboration

Includes strategies like:

- Credit for prior learning
- > Work-based learning
- Project-based learning
- Skills-based assessment
