Overdue Counties

Sara Jaggers explained the counties listed that she updated in the Overdue Counties document, which was sent in the invitation for the group to review prior to this meeting. After discission with Lori, Sara sent an email to Bath County offering them two different extensions to apply for giving them more time to rebuild after loosing their leadership. During the last meeting, the group decided that committee members would assist Sara with reaching out to the counties and were supposed to set-up meetings with them to discuss their WRC status. Sara will continue to reach out to counties and will include the committee with any meetings that are scheduled, especially in-person time as counties appreciate

Review of WRC Process and Criteria Discussion

Lori and Sara led the discussion with the committee about how to benefit the communities within the process instead of being stuck to checking boxes from criteria that has been held in the past. The committee had great thoughts and discussion about revamping the process as Jeremy Faulkner expressed that the ultimate goal of the certification has gotten lost over the years. Myra Wilson stated that she has spoken with several counties that have concerns about participating because it doesn't seem worth the time that it takes to complete the application.
